### **Introduction**

FC Battersea Ltd is a 'not for profit' youth football club which includes the FC Battersea Foundation. This privacy policy will explain how our organization uses the personal data we collect from you when you use our website or the like.

### **What data do we collect?**

Our Company collects the following data:

- Personal identification information (eg, name, email etc)
- Player data (eg, DOB, previous club, images etc)
- Payment data (eg, holiday camps, clubshop)

### **How do we collect your data?**

You directly provide our Company with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.
- Use or view our social media

Our Company may also receive your data indirectly from the following sources:

- Company related 3<sup>rd</sup> parties (eg, The FA, Tandridge League, Stripe, Spond etc)

### **How will we use your data?**

Our Company collects your data so that we can process:

- Player registration
- Fixture and event notification
- CWO matters
- Process your payment (eg, club shop, holiday camp etc)
- Contact you with relevant Company information

Our Company may share your data with our partner companies so that they may offer you their products and services.

### How do we store your data?

Our Company securely stores your data on secure website servers, Dropbox or the like

Our Company will keep your data for 12 years. Once this time period has expired, we will delete your data unless otherwise notified.

### What are your data protection rights?

Our Company would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request Our Company for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** – You have the right to request that Our Company correct any information you believe is inaccurate. You also have the right to request Our Company to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that Our Company erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that Our Company restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to Our Company's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that Our Company transfer the data that we have collected to another organization, or directly to you, under certain conditions.
